III. Officers' Reports

A. President's Report

President Sue Hughes talked about what the Friends spends their hard-earned money on. Topping the list is the new outdoor sign for the Library. Installation should be completed by the end of this month. The comfy chairs in the Lane Room were a gift from the Friends. Two laptop computers were purchased for use in video presentations and computer classes. Friends purchased a buffing machine for repair of CDs and DVDs, a definite cost-savings device. The museum passes for Hampton residents were paid for by the Friends. Additionally, Friends helps with mailing costs, and numerous other items. Friends is especially proud to be contributing to the renovations in the Reference Area of the Library by helping to pay for the new Reference Desk. Sue then listed some of the fund-raising events that Friends sponsors in order to raise the funds for Library purchases: Book sales twice a year; Centre School 1st graders book sales, twice a year; the summer Red Sox Tickets raffle; the doll clothes sales twice a year.

B. Treasurer's Report

Treasurer Connie George stated that there is currently \$16,910.24 in the checking account; \$7,535.92 in the savings account; and approximately \$5,000 in the CD, which will mature in April 2012. Total assets are \$29,943.25.

C. Membership

Lynn Blume reported that membership is up to 320. Lynn endeavors to contact every member who joins anew or renews. There were over 5,000 flyers mailed out in the Spring of 2010, with very good response. She is still gathering e-mail addresses for members, which would help to reduce mailing costs.
